The fund may hold positions in the debt and equity securities of small, medium and large capitalization companies. Debt securities purchased directly by the Fund can be of any credit quality and may be of any maturity and duration. The Fund monitors each holding and adjusts the portfolio as necessary to reflect changes in each security's fundamentals and valuation.
